All of the Regimental and the Veteran's Service Records (except where otherwise noted) are from the Compiled Service Records of Confederate Soldiers who served in organizations from the State of Alabama that is currently on microfilm.

Regimental Return

June 1862

Camp near Tupelo, Miss.

This Reg't left Corinth, Miss. night of the 29th May 1862 enroute for this place. Bivouac at Clear Creek June 2, 1862 when we received orders on the 3rd June to return to Blackland to do picket or outpost duty. Where on the 4th June the regiment was attacked by a superior force of Federal Cavalry. The Confederate force consisted of this Reg't, a portion of the 24th Ala. Reg't, a section of Burtwell's battery and about 300 cavalry. After a short but terrific fire the enemy was driven from the fields.

Loss unknown. This Reg't had five wounded – none killed. On the 6th of June the Reg't began the march to this place a distance of 30 or 35 miles – where we arrived on June 8.

Since that time the Reg't has been studiously engaged in drilling & disciplining.

Company organized, officers elected July 6, 1861.

Muster roll filed with A. I. General Monty, Ala. 17 July 1861.

Orders issued 29th day of July 1861 to march to Auburn, Ala.

On the 19th of August took off the line of march from Jonesboro, Ala.

March 29 miles to Montevallo, Shelby Co., Ala. transportation furnished

thence to Auburn, Macon Co., Ala.

Company mustered into service Maj. J. L. Calhoun Aug 31, 1861.

Co. left Auburn, Ala. Oct 31, 1861.

Arrived at Huntsville, Ala. Nov. 1, 1861.

Left Huntsville Nov 8 & arrived at Mobile Nov. 10, 1861.

Dec. 31, 1861 to Aug. 31, 1862

Camp Beulah near Mobile

It is impossible for the present Co. Commander to mention the many picket fights in which it was engaged before leaving Corinth in as much as I was not with the Company at that time.

The company left the entrenchments two miles north of Corinth, Mississippi about eleven P.M. May 28, 1862 and continued the march until four the following evening.

We stopped for a few days at Clear Creek - ? miles below Corinth.

On the 3rd of June we returned to the rear four miles to Blackland and was engaged in the

skirmish of the fourth.

The company was commanded on this occasion by (M. or W.) Harker. No men were killed or wounded from the company. The following day we were withdrawn one mile and on the seventh took up the line of march for this point. The company arrived at Tupelo on the 9th, removed to Saltillo, staid (stayed) a few weeks and on the 1st of Aug. started for this point. The company has improved much in discipline and drill.

Nothing of interest has transpired in the last two months. The company is very pleasantly situated four miles from the City of Mobile on the Spring Hill Road and is enjoying good health. Two deaths have occurred in the last two months from the fatiguing retreat from Corinth, Miss.
